1) Organizational Conflicts Of Interest

a) Definitions.

"Contractor" means the person, firm, unincorporated association, joint venture, partnership, or corporation that is a party to this contract.

"Contractor and its affiliates" and "Contractor or its affiliates" refers to the Contractor, its chief executives, directors, officers, subsidiaries, affiliates, subcontractors at any tier, and consultants and any joint venture involving the Contractor, any entity into or with which the Contractor subsequently merges or affiliates, or any other successor or assignee of the Contractor.

An "Organizational conflict of interest" exists when the nature of the work to be performed under a proposed ordering activity contract, without some restriction on ordering activities by the Contractor and its affiliates, may either (i) result in an unfair competitive advantage to the Contractor or its affiliates or (ii) impair the Contractor's or its affiliates' objectivity in performing contract work.

1. SERVICE AREAS

2. LOSS OR DAMAGE

When Telos moves equipment to its OEM location for repairs, Telos shall be responsible for any damage or loss, from the time the equipment is removed from the ordering activity installation, until the equipment is returned to such installation.

3. SCOPE

a. Telos shall provide maintenance for all equipment listed herein, as requested by the ordering activity during the contract term.

b. Equipment placed under maintenance service shall be in good operating condition.

i) In order to determine that the equipment is in good operating condition, the equipment shall be subject to inspection by Telos, without charge to the ordering activity.

ii) Costs of any repairs performed for the purpose of placing the equipment in good operating condition shall be borne by Telos, if the equipment was under Telos/OEM guarantee/warranty or maintenance responsibility prior to the effective date of the maintenance order.

iii) If the equipment was not under Telos/OEM responsibility, the costs necessary to place the equipment in proper operating condition are to be borne by the ordering activity, in accordance with the provisions of the contract.

4. RESPONSIBILITIES

- a. If the Ordering Activity task or delivery order specifies a factory authorized/certified service personnel then Telos is obligated to provide such a factory authorized/certified service personnel for the equipment to be repaired or serviced, unless otherwise agreed to in advance between the Ordering Activity and Telos.
- c. Hardware maintenance and/or service repair shall be authorized by the OEM.

5. MAINTENANCE RATE PROVISIONS

- a. Telos shall bear all costs of maintenance, including labor, parts, and such other expenses as are necessary to keep the equipment in good operating condition, provided that the required repairs are not occasioned by fault or negligence of the ordering activity.
 - i. **REGULAR HOURS:** The basic monthly rate for each make and model of equipment shall entitle the ordering activity to maintenance service during a mutually agreed upon nine (9) hour principal period of maintenance, Monday through Friday, exclusive of holidays observed at the ordering activity location.
 - ii. **AFTER HOURS:** Should the ordering activity require that maintenance be performed outside of regular hours, charges for such maintenance, if any, will be \$140 per hour, with a two-hour minimum for equipment under on-call maintenance service.

Automated Messaging Handling System (AMHS)

The Telos AMHS (Automated Message Handling System) is a computer-assisted method of receiving, disseminating, transmitting, archiving and retrieving message traffic that arrives at a site from a variety of sources that may have a particular format and protocol associated with its transmission. The AMHS may be configured based on customer requirements to segregate messages by message source, organizational address, and/or discretionary access controls. The AMHS connects to the DMS using the CommPower XML CommPower XML Portal (CP-XP) to support both inbound and outbound message processing. The CP-XP/AMHS implementation centralizes the organizations DMS certificate eliminating the requirement for the organization to manage and distribute the certificates to its users, which results in significant maintenance savings.

The AMHS provides the organization's user community with an intuitive web based client, AMHS Online, where the user can read, forward, save, or delete messages that have been disseminated to them based on addressing, content-based decision (profiling) rule-based logic or organization structure. Using AMHS Online the user has the capability to create, coordinate, and release messages into the AUTODIN, the DSSCS, or the DMS utilizing user friendly message forms.
